Respected Sir,

With great regards for your esteemed self, your kind attention is invited towards the most important HR issue i.e. promotion of JTO (T) to SDE (T) under SCF quota. As your good self may be aware that Personnel section of BSNL CO has initiated the pre-preparatory work for the promotion of JTOs (T) to the post of SDE (T) under the SCF quota up to vacancy year 2010-11 only. Surprisingly in the year 2018, the available vacancies taken into consideration are only up to the year 2010-11.

Here it is pertinent to mention that at present around 10,000 posts of the SDEs are vacant in the field units and thousands of officers have already completed the requisite residency period and are waiting for their 1st promotion in BSNL since long back. Conducting the DPC/CPC for the vacancy year up to only 2010-11 in year 2018 is neither logical, legitimate nor sufficient to meet the shortage of the SDEs in the field units apart from delaying promotions to those Executives who have already completed the requisite residency period years back and are also eligible to be included in this exercise of the DPC/CPC.

SDE recruitment rule does not say anything on whether the LDCE is to be conducted first or the DPC/CPC for a particular vacancy year.BSNL itself has conducted the DPC/CPC earlier than the LDCE for the same vacancy year at several occasions in the past. Now on the pretext of the non-conduction of the LDCE, withholding the DPC/CPC for the corresponding vacancy years is not at all justified and is a double attack on the limited and legitimate promotional avenues available to the young officers in BSNL.
