## Respected Sir,

Greetings!! We are thankful to your esteemed self for taking the personal cognizance of genuine & legitimate issue of pay anomaly of direct JTOs of 2007 & 2008 batches of BSNL recruited in E1A pre-revised. With respect to our earlier meetings with your kind self at Sanchar Bhawan & Dak Bhawan respectively and representations thereto vide letters referred above, following is submitted for your kind consideration please.

- Even after intervention of your good office, a superficial & irrelevant reply from Sr. GM (Estt.), BSNL CO received wherein the genuine & legitimate issue of pay fixation of direct JTOs of 2007 & 2008 batches of BSNL recruited in E1A pre-revised was denied without giving due attention to the contradictions & anomaly existing in Committee report for this case. The matter was well brought into notice of BSNL Management by AITEEA several times.
- 2. To dilute this genuine issue, BSNL Establishment has suo motto expanded the purview of Committee report for all post 2007 Executives whereas it was the case of only those Executives who were appointed in E1A pre-revised. Moreover it is a matter of unequal treatment among equal set of Executives recruited in E1A pre-revised pay scale. Anomaly in brief depicted through following table :

Due to the above we are getting Rs 5700/ less compared to our pre revised salary i.e. We would get Rs 5700 more if we were continued in our appointment pay scale [9850-14600].

3. BSNL Establishment have ignored policy decision of Supreme Court in P. Savitha vs. Uol wherein it is precisely stated that the difference in basic pay between senior & junior working in same pay scale (E1A), recruited through same RR, having same eligibility, will have number of increments corresponding to number of years traversed by former than latter. However where Management has to favor some sections, they have no hesitation to take the cognizance of judgment of Supreme Court. In such one case of recovery, BSNL has favored some employees by suo motto taking cognizance of third party judgment of Supreme Court vide letter issued from Estb. Cell of BSNL CO no.1-6/ 2016-PAT (BSNL) dated 08.03.2018 recently wherein neither petitioner nor respondent was from/to BSNL.

Such a discriminatory practice & selective appeasement by BSNL Management has not only demotivated our young work force but attracted many unwarranted litigations resulting in waste of time & energy ultimately making loss to the Company & Nation.

We sincerely submit before your esteemed self to intervene to resolve this pay anomaly issue of young Executives in the best interest of BSNL and our Nation thereto.
