## Respected Madam,

With due regards for your esteemed self, in reference to the subject mentioned above, this is to submit that since eight to nine years have elapsed after joining in BSNL as graduate engineer in JTO cadre, none of promotion avenues have been opened for us till date, neither by DPC nor through departmental fast-track promotion examination. This has led huge disappointment, anger & frustration among worth young Executives, which is overall hampering the growth of our company.

Following facts are submitted for your kind perusal & necessary action please.

1. On dated 10.12.2014, BSNL recruitment section has notified for the LDCE promotions under 33% quota from JTO (T) to SDE (T) for the vacancy years 2010-11, 2011-12, 2012-13, 2013-14 vide F. No. 24-1/2014-Rectt.[Ref-1].

2. Later due to instructions of Honorable CAT, Guwahati for the conduction of separate examination for each vacancy year, BSNL deferred all these examinations till further orders [Ref-2].

3. Afterwards BSNL Management conducted only one exam for 2010-11 vacancy years only & for the other vacancy years (2011-12, 2012-13, 2013-14), this exam was kept pending due to unknown reasons as no court has restricted conduction of any such exam. [Ref-3]

4. BSNL Recruitment section, vide letter F. No. 78-1/2016-Rectt dated 17.02.2016, has notified an Examination calendar wherein the date of LDCE, JTO(T) to SDE(T) for further vacancy years 2011-12,2012-13,2013-14 was put in schedule. However recruitment section failed to conduct these exams to their due dates without any valid reason. [Ref-4]

It is painful to mention that post 2007 executives are already facing anomaly in their pay fixation since years and issue of their pay scale with respect to second PRC is still pending & now in promotion too, they are again deprived of their basic promotions. In this regard, it is submitted before your kind self to intervene & arrange to issue necessary instructions to personnel & recruitment section for the immediate conduction of all pending DPC & LDCE, JTO(T) to SDE(T) for vacancy years up to 2016-17at the earliest please.
